**GWCA Board Meeting Minutes**  
**Thursday, June 20/24 @ 7:00 PM via Teams**

- Present: Ken Paige, Anthea Hoare, Mike Brown, Stephen Groom, Derek Remes
- Absent: Joan Griffin, Shane Titus, Ilde DeBerradinis
  
- **Welcome**
  - Motion to accept and approve agenda – with changes to the day (Thursday) and forum (Teams)
  - Motion to accept and approve meeting minutes of May 22/24 – no changes, Mike moved, seconded by Derek
  
- **Updates**
  - **Community Engagement**
    - Stephen attended Town of Halton Hills Arts and Culture Board meeting representing GWCA: Arts & Culture Board have been handing out rack notes for local businesses for 2024 Culture Days; Stephen will hand these out for this year since GWCA has a full plate with 2024 planned projects/events; next year we will engage them for the Glen200th
    - Meeting in June for the Glen Williams Secondary Plan to be rescheduled for the Fall
  
  - **Parks & Trails**
    - May 25<sup>th</sup> native tree planting partnership with CVC in the Glen Park saw a good turnout of residents volunteering despite the rain; 95 trees planted along river
    - Keller Williams Plaque on new bench are in place at the Shelagh law Parkette. Halton Hills Today published an article on this with a reference to GWCA mention given our funding contribution to the bench.
    - Kiosk to be done by September for the fall before winter sets in; Home Hardware is sponsoring funds for all materials, Joan working with the Sign Shop exploring solutions for production of map and acknowledgement plaque; need to set a date for the unveiling celebration – this could fit within the Town of Halton Hills 2024 Culture Days; Town can help with advertising
  
  - **Development**
    - Development sub-committee (Joan, Mike, Stephen) met to discuss status of all active and planned developments in the Glen
    - Megan McMaster construction has started – residents on Wildwood Rd. can get a sewer connection if they are willing to pay for it; an option for future connection is also available
    - The “Field” with planned entrance off Confederation St.; no actions at this time; Eden Oak (developer) using the laneway with a waste bin at the end at the walkway, dropped off

equipment, took down the golf club residents had made and removed the benches; left a construction trailer

- 102 Confederation St. developer Glen Williams Estates have moved some equipment into property and cleared some trees
- For Bishop Court, currently reviewing lates submission of developer and working on our issues list; looks like developer are dredging the pond and re-doing it; will look into this
- Bill 185 attained Royal Assent on June 6, 2024 and this legislation now precludes third party appeals for OP, OPAs, Zoning Bylaws, Zoning By-law Amendments.
- **Action:** Need to explore impact on GWCA regarding appeal rights; and impact on status at upcoming OLT hearings. The date that this takes effect would be for any hearings booked on or after April 10, 2024.

- **Traffic**

- Concerning issues of increased cut throughs, speeding and safety of residents, there was a walk around the area of Erin St., Alexander St. and Beaver St. with Joan, Ilde and (a resident who has expressed an interest in supporting with traffic issues) and Councillor Brass; Councillor Brass committed to supporting solutions to mitigate current safety concerns
- Councillor Brass made aware by a truck driver on Confederation St. that the signage said they were allowed to be here; upon investigation it appears there was a sticker on the sign at Mountainview and River Rds. that may have fallen off which led trucks to believe travelling into the Glen during the day was ok; Councillor Brass advised Town staff and they have rectified this; should hopefully cut down on truck traffic in the Glen
- Dereck mentioned that Class A trucks are not allowed, Class B do deliveries; our roads are not designed for them

- **Glen200**

- Mike reported that Glen200 Residents Working Group is working with Mark Rowe an historical newspaper to be given out at the Canada Day Parade; 1000 copies will be made; will include the winning Glen200 logo which can be used on any media; newspaper will highlight planned events throughout the year including September 27<sup>th</sup>, 2025 special all day celebration events; looking for volunteers to hand out at July 1<sup>st</sup>; already have 2 high-school students from the GLT youth company and Anthea will ask for a few more volunteers
- Ken asked if it would be appropriate to ask the owners of the original school house to open for the celebration and we will look into this
- Follow up meeting with the working group meeting in mid-July
- Year long photo contest will launch Sept. 2024
- **Action:** ask the owners of the original school house to open for the Glen200 celebration

- July - Canada Day Booth & Fundraiser – Finalized details
- September – Lunch/Bingo Fundraiser – need to begin planning, working with Isobel Halliday for dates; using Glen Town Hall
- October – Community Information Open House – began planning discussion, board confirmed location to be Glen Town Hall; discussed what stations should we have; last year guests included Halton Police, Shelagh Law Parkette, Birds for Halton, Credit Valley Trails, Town of Halton Hills

Transportation and Planning staff; Halton Hills Climate Action Group; Ken, Larissa, others as needed will help
